- Recently funded project-The Concrete Bridge Engineering Institute (CBEI), CBEI is the center of concrete bridge related research, education, and training at the University of Texas at Austin in the Cockrell School of Engineering. There will be classroom and hands-on training in 3 areas: debt construction, concrete materials to extend the life of concrete bridges and a post tensioning academy to provide hands-on training for the field of solar and inspectors.

 - Legislature's regular session is ongoing and will run through the end of this month. There are several areas related to Technology, Research and Innovations in Mobility, across the areas of Electrification Data and Data privacy connected to Autonomous Vehicles and Advanced Air Mobility to name a few.
 - If the Electric Vehicles (EV) fee bill passes it will require owners to pay an annual registration fee to offset the cost of gas tax revenue on electric vehicles.
 - There is also a bill that focuses on the Council of State agencies that would plan Electrification statewide into the distant future (2040-2050).
 - There are 5 Autonomous Freight Companies still operating in the State. Two of them have announced plans to be driverless within the next 2 years.
 - During the Intelligent Transportation Systems (ITS) of America conference there was a lot of discussion on Connectivity and Digital Infrastructure. More details to come.
 - Departmental discussions on Traffic Management Centers and what the advancement would be in the future relative to Autonomy as well as data received

from vehicles and how it can enhance safety operations for the State.

- The Snow Plowing Panhandle Research Project is in discussion to scale the project through the Fleet Division across the State.
- Strategy for Connected and Autonomous Development in the State was approved, and work has begun to advance the program.
- Innovation Alliance is hosting an Innovation Invitational with its team members on July 17- 19th.
